**NOTES:**

1. In terms of CAR issued by DGCA File No. 23-16/2016-AED effective 1st of August 2016 **under no circumstances, the cancellation charge shall be more than the basic fare plus fuel surcharge.** ( In Air India on domestic Fuel charge is already merged with Basic Fare )
2. JN (Service Tax), F2 ( Swacch Bharat Cess ) and G1 ( Krishi Kalyan Cess) are included in charges being levied against cancellation policy.
3. Business Rules of RBD- Y would apply both for HLTC, Armed Forces Discount.
- 4 \*\* ( RBDs - H, K, Q, V,W, G, L, U,T, S & E) on no -show are non -refundable with forfeiture of basic.
